Requirements

To comply with the government's legislation regarding data (called General Data Protection Regulations (GDPR)) that is effective from 25.05.2018.

Policy

Vegan Runners UK (The Club) is committed to protecting and respecting your privacy. For any personal data you provide for the purposes of your membership, The Club is the Data Controller and is responsible for storing and otherwise processing that data in a fair, lawful, secure and transparent way.

What personal data do we hold on you?

You may give us information about you by filling in forms at an event or online or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register with The Club. The information you give us may include your name, date of birth, address, e-mail address, phone number, gender, name of the England Athletics (EA) affiliated clubs with which you are registered (Athletics Data).

Why do we need your personal data?

The reason we need your Athletics Data is to be able to administer your membership and provide the membership services you are signing up to when you register with The Club. Our lawful basis for processing your personal information is that we have a contractual obligation to you as a member to provide the services you are registering for.

Reasons we need to process your data include:

For training and competition entry

Sharing personal data with club coaches or officials to administer training sessions

Sharing personal data with club team managers to enter events

Sharing personal data with leagues, county associations and other competition providers for entry in events

For funding and reporting purposes

Sharing anonymised data with a funding partner as condition of grant funding e.g. Local Authority

Analysing anonymised data to monitor club trends

Sending an annual club survey to improve your experience as a club member

For membership and club management

Processing of membership forms and payments

Sharing data with committee members to provide information about club activities, membership renewals or invitation to social events

Club's newsletter promoting club activity

Publishing of race and competition results

Marketing and communications

Sending information about promotions and offers from sponsors

Sending information about selling club's kit, merchandise or fundraising

The Club uses the following social media pages: Facebook, Twitter, Instagram. All members are free to join these pages. If you join one of the social media pages, please note that providers of the social media platform(s) have their own privacy policies and that The Club does not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club's social media pages.

Who do we share your personal data with?

When you become a member of Vegan Runners UK, you can also choose to be registered as a member of England Athletics Limited (EA). If you would like to register as a member of EA, please tick the box on the application form, and we will provide EA with your Athletics Data which they will use to enable access to the MyAthletics online portal. EA will contact you to invite you to sign into and update your MyAthletics portal. You can set and amend your privacy settings from the MyAthletics portal. If you have any questions about the continuing privacy of your personal data when it is shared with EA, please contact their Data Protection department at: dataprotection@englandathletics.org. If you choose not to add EA membership, then we will not share your data with EA.

The Club does not supply any personal data it holds for this purpose to any other third party. The Club does not store or transfer your personal data outside of the UK.

How long do we hold your personal data?

We will hold your personal data on file for as long as you are a member with us. Athlete data is updated every year on annual membership forms. Any personal data we hold on you will be securely destroyed after four years of inactivity on that member's account, in line with EA's retention policy. Your data is not processed for any further purposes other than those detailed in this policy.

Your rights regarding your personal data

As a data subject you have the right to: request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data, including direct marketing; to the portability of your personal data and to complain to the UK's data protection supervisory authority about the processing of your personal data.

As a data subject you are not obliged to share your personal data with The Club. If you choose not to share your personal data with us, we may not be able to register or administer your membership.

Data storage and access

The Club stores data using the “Membermojo” system. This system manages membership applications and membership renewals for The Club. Their GDPR statement is below but further details can be found here: <https://membermojo.co.uk/mm/help/gdpr>

“Membermojo General Data Protection Regulation (GDPR)”

membermojo provides online membership services for organisations.

In data protection terms we are the data processor for your organisation member data, and your organisation is the data controller. ([ICO key definitions](#))

We provide the tools and controls that help implement your organisation's GDPR compliant privacy policy for managing personal member data.

This includes:

- *What personal data is stored - you define the personal data (membership form) that needs to be held for your organisation.*
- *Gaining consent - your form can include 'accept terms' fields that must be ticked before the form completes. We store the date that the application, and therefore the consent, was completed.*
- *Where data is stored - all servers and backups are hosted in secure UK facilities.*
- *How data is protected - we provide security and access controls for your member data.*
- *How long data is kept for - you define how long personal data is retained and we automate the deletion.*

We also provide functions that assist members and administrators to exercise individual rights under GDPR.

- *Right to access - members can sign in to view their own personal data.*
- *Right to rectification - members can sign in and amend their own personal data.*
- *Right to Erasure - administrators can securely delete personal data for members requesting their data be erased. Erasing a member will remove their member record and anonymise any activity, attendance and (optionally) payment records.*

Access to ‘Membermojo’

Access to the data on ‘Membermojo’ is limited to the administrators (committee members) for the reasons given above.

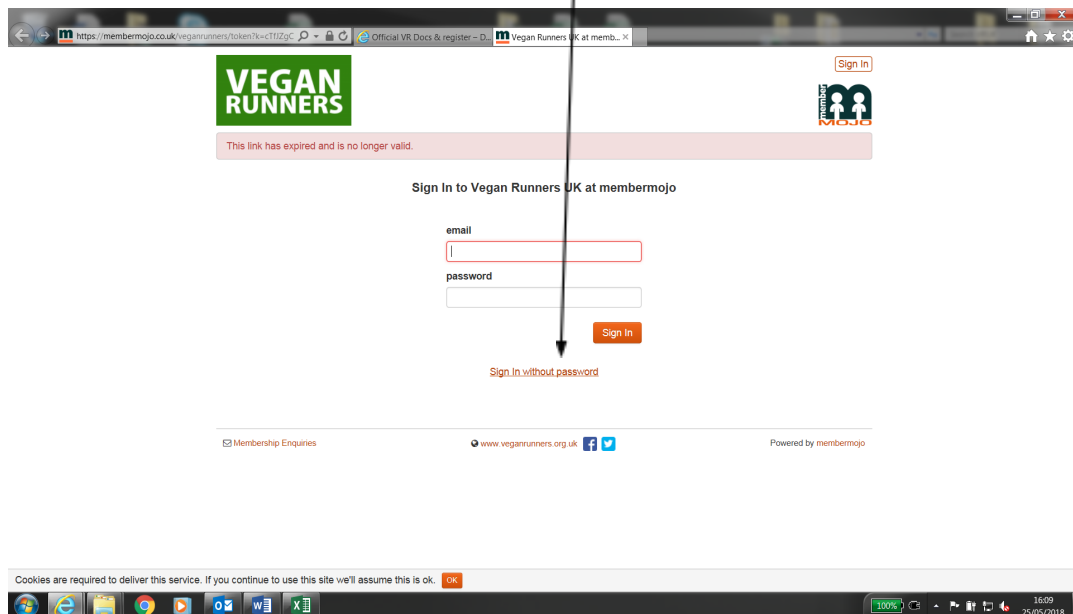
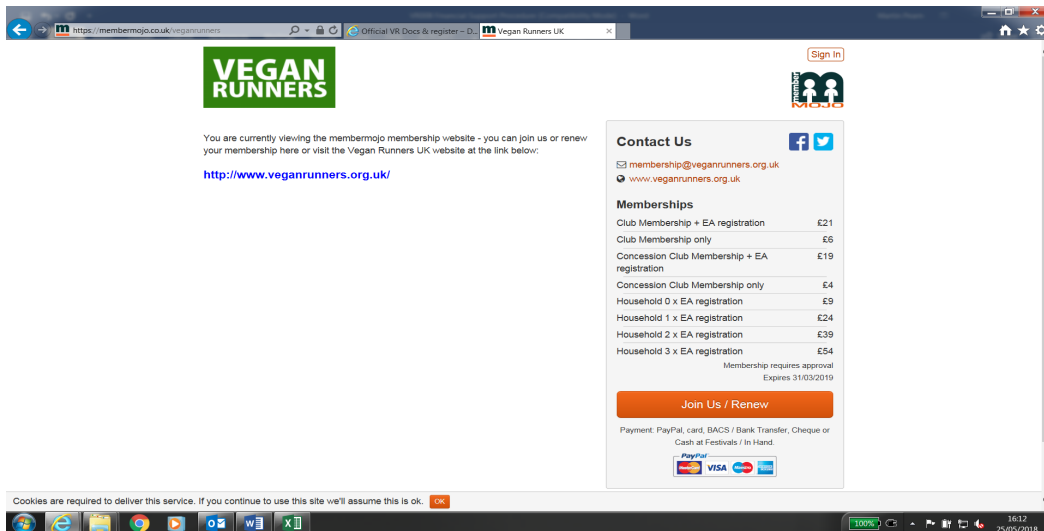
All members have the ability to manage their personal data themselves by editing their profile as required.

To access and edit your personal data please follow these steps:

Click on the “Sign in button





- 3) Once you have logged in, you can edit your personal details.
 4) If you wish to be removed from non essential emails, contact the membership secretary and request that you be excluded from general emails and wish to only receive essential correspondence such as membership renewal.
